- Must be in good business standing with the State of California.

*California STEP funding for Milipol Asia-Pacific will be offered to STEP-eligible California small business on a first come, first served basis.*

**COST: \$8,800.00\***

*\*The California STEP program will reimburse up to 4 eligible California small businesses a maximum of \$5,000 USD each for exhibition costs.*

**SPACE:** Limited to four(4) California STEP-eligible small businesses.
